**NOTICE OF APPLICATION**  
**PARKPLACE CENTER, PERMIT NO. SPL09-00001**

**PROPOSAL:** Douglas Howe, the applicant, is requesting a Short Plat Permit to subdivide one parcel known as Park Place Center, which totals 11.51 Acres into 2 lots within the CBD-5A Use Zone. The proposed lot sizes are 8.69 Acres (LOT 1) & 2.82 Acres (LOT 2). The application was received by the City on March 24, 2009 and was deemed complete on April 7, 2009.

**LOCATION:** 130 PARKPLACE CENTER

**REVIEW PROCESS:** The decision on this application will be made by the Planning Director. Prior to the decision, there is an opportunity for the public to submit written comments, as described below. The Director will also receive a report from the Planning Department staff making a recommendation on the application. The decision will be based on whether the application complies with Kirkland's Subdivision Code and other applicable codes.
